

## American Realities Volume 2 8th Edition

This book is an insider’s account of the search for missing American servicemen who became trapped in the Soviet Union and the US government’s efforts to free them or discover their fates. The book, which is based on years of work as a consultant to the US government, includes archive research that took place in Russia and four other republics of the Soviet Union as the USSR broke apart. Volume I explores the history of missing American servicemen, with particular emphasis on thousands who were not accounted for during the Korean War and Cold War era. As US relations with Russia and North Korea become more intense, this book is an extremely timely resource for scholars, laymen, and policymakers.

His life and careers were so varied and successful that he remains, even today, the epitome of the self-made man. Born into a humble tradesman's family, this adaptable genius rose to become an architect of the world's first democracy, a leading light in Enlightenment science, and a major creator of what has come to be known as the American character. Journalist, musician, politician, scientist, humorist, inventor, civic leader, printer, writer, publisher, businessman, founding father, philosopher, Franklin is a touchstone for America's egalitarianism. Volume 2 takes Franklin from his marriage in 1730 to his retirement as a printer at the beginning of 1748, examining the mysteries of the illegitimate William Franklin's birth and mother and Franklin's increasing civic activities--starting the Library Company in Philadelphia in 1731, forming Pennsylvania's first volunteer fire company, and becoming an advocate for a clean Philadelphia environment. J. A. Leo Lemay assesses Franklin's numerous writings, attributing to him for the first time a deistic Indian speech, remarking on his use of the second African American persona in journalism, and analyzing his publishing sensation of 1747, The Speech of Miss Polly Baker. These belletristic works are complemented by Franklin's religious, political, and scientific writings, which he produced prodigiously.

The deep divides that define politics in the United States are not restricted to policy or even cultural differences anymore. Americans no longer agree on basic questions of fact. Is climate change real? Does racism still determine who gets ahead? Is sexual orientation innate? Do immigration and free trade help or hurt the economy? Does gun control reduce violence? Are false convictions common? Employing several years of original survey data and experiments, Marietta and Barker reach a number of enlightening and provocative conclusions: dueling fact perceptions are not so much a product of hyper-partisanship or media propaganda as they are of simple value differences and deepening distrust of authorities. These duels foster social contempt, even in the workplace, and they warp the electorate. The educated -- on both the right and the left -- carry the biggest guns and are the quickest to draw. And finally, fact-checking and other proposed remedies don't seem to holster too many weapons; they can even add bullets to the chamber. Marietta and Barker's pessimistic conclusions will challenge idealistic reformers.

Since the 1990s and the recent rise of the Black Lives Matter movement, there has been a rise in diverse racial representation on television. In particular, Black characters evolved and began to move away from racial stereotypes. In this collection of essays, the representation of Black characters in professionally defined careers is examined. Commentary is also provided on the portrayal of Black people in relation to stereotypes alongside the importance of Black representation on screen. This work also introduces the idea of the Black-collar category to highlight the Black experience in white-collar jobs. The essays are divided into six parts based on themes, including profession, and focuses on a select number of Black characters on TV since the 1990s.
