This fourth volume of PISA 2012 results examines how student performance is associated with various characteristics of individual schools and school systems.

This edited volume addresses the impacts of climate change on Pacific islands, and presents databases and indexes for assessing and adapting to island vulnerabilities. By analyzing susceptibility variables, developing comprehensive vulnerability indexes, and applying GIS techniques, the book's authors demonstrate the particular issues presented by climate change in the islands of the Pacific region, and how these issues may be managed to preserve and improve biodiversity and human livelihoods. The book first introduces the issues specific to island communities, such as high emissions impacts, and discusses the importance of the lithological traits of Pacific islands and how these physical factors relate to climate change impacts. From here, the book aims to analyze the various vulnerabilities of different island sectors, and to formulate a susceptibility index from these variables to be used by government and planning agencies for relief prioritization. Such variables include tropical cyclones, built infrastructures, proximity to coastal areas, agriculture, fisheries and marine resources, groundwater availability, biodiversity, and economic impacts on industries such as tourism. Through the categorization and indexing of these variables, human and physical adaptation measures are proposed, and support solutions are offered to aid the inhabitants of affected island countries. This book is intended for policy makers, academics, and climate change researchers, particularly those dealing with climate change impacts on small islands.

This book aims to wrest the concept of narcissism from its common and pejorative meanings— egotism and vanity—by revealing its complexity and importance. DeArmitt undertakes the work of rehabilitating “narcissism” by patiently reexamining the terms and figures that have been associated with it, especially in the writings of Rousseau, Kristeva, and Derrida. These thinkers are known for incisively exposing a certain (traditional) narcissism that has been operative in Western thought and culture and for revealing the violence it has wrought—from the dangers of amour-propre and the pathology of a collective “one’s own” to the phantasm of the sovereign One. Nonetheless, each of these thinkers denounces the naive denunciation of “narcissism,” as the dangers of a non-negotiation with narcissism are more perilous. By rethinking “narcissism” as a complex structure of self-relation through the Other, the book reveals the necessity of an im-possible self-love.

This textbook provides comprehensive yet concise coverage of all the topics covered in Unit A451: Computer Systems and Programming of the OCR GCSE Computing Specification J275, written and presented in a way that is accessible to teenagers. It will be invaluable both as a course text and as a revision guide for students nearing the end of their course. It is divided into seven chapters corresponding to the seven sections of the specification, each ending with a "Glossary of terms" and exam questions from past OCR GCSE papers.

This book makes the mathematical basis of formal methods accessible both to the student and to the professional. It is motivated in the later chapters by examples and exercises. Throughout, the premise is that mathematics is as essential to design and construction in software engineering as it is to other engineering disciplines. The exercises range from simple drills, intended to provide familiarity with concepts and notation, to advanced material. The first four chapters of the book are devoted to foundations, with an introduction to formal systems, then the propositional and predicate calculi, concluding with a chapter on theories in general. The second part of the book builds upon the foundations by covering in detail the theory of sets, relations, functions, and sequences. The mathematical data types then presented are powerful enough to describe many aspects of software systems, and small case studies are included as examples of their use in the modelling of software: a configuration manager, a storage allocator, and a simple backing store interface. The concrete syntax of the Z notation has been adopted. The third part of the book presents two detailed case studies in the use of mathematics in software engineering. The first is the specification of the behaviour of a telephone exchange, and the second illustrates the importance of the development of a mathematical theory in gaining an understanding of a system. Both case studies stress the roles of modelling and of proof in the construction of specifications. The final part describes the algebraic approach to specification and then summarizes and compares the various formal techniques.

One ofthe most important aspects in research fields where mathematics is "applied is the construction of a formal model of a real system. As for structural relations, graphs have turned out to provide the most appropriate tool for setting up the mathematical model. This is certainly one of the reasons for the rapid expansion in graph theory during the last decades. Furthermore, in recent years it also became clear that the two disciplines of graph theory and computer science have very much in common, and that each one has been capable of assisting significantly in the development of the other. On one hand, graph theorists have found that many of their problems can be solved by the use of com puting techniques, and on the other hand, computer scientists have realized that many of their concepts, with which they have to deal, may be conveniently expressed in the lan guage of graph theory, and that standard results in graph theory are often very relevant to the solution of problems concerning them. As a consequence, a tremendous number of publications has appeared, dealing with graphtheoretical problems from a computational point of view or treating computational problems using graph theoretical concepts.

There are two key questions at the heart of the ongoing debate about education and training for all young people, irrespective of background, ability or attainment: What counts as an educated 19 year old today? Are the models of education we have inherited from the past sufficient to meet the needs of all young people, as well as the social and economic needs of the wider community? Education for All addresses these questions in the light of evidence collected over five years by the Nuffield Review of 14-19 Education and Training; the most rigorous investigation of every aspect of this key educational phase for decades. Written by the co-directors of the Nuffield Review, Education for All provides a critical, comprehensive and thoroughly readable overview of 14-19 education and training and makes suggestions for the kind of education and training that should be provided over the coming decade and beyond. The authors acknowledge that much has been achieved by the respective governments – massive investment in resources; closer collaboration between schools, colleges, training providers, voluntary agencies and employers; recognition and promotion of a wider range of qualifications. They are also optimistic about the good things that are going on in many secondary classrooms – enormous amounts of creativity; courageous efforts to meet problems; a deep concern and caring for many young people otherwise deprived of hope and opportunity. But they argue for a radical reshaping of the future in the light of a broader vision of education – a greater respect for more practical and active learning; a system of assessment which supports rather than impoverishes learning; respect for the professional expertise of the teacher; a more unified system of qualifications ensuring progression into higher education and employment; the creation of strongly collaborative and local learning systems; and a more reflective and participative approach to policy. Education for All should be read by everyone working in – or with an interest in – secondary-level education in England and Wales and beyond.

This collection of more than two dozen essays by philosophy scholars of international repute traces the profound impact exerted by Husserl's Meisterwerk, known in its shortened title as Ideen, whose first book was released in 1913. Published to coincide with the centenary of its original appearance, and fifty years after the second book went to print in 1952, the contributors offer a comprehensive array of perspectives on the ways in which Husserl's concept of phenomenology influenced leading figures and movements of the last century, including, among others, Ortega y Gasset, Edith Stein, Martin Heidegger, Aron Gurwitsch, Ludwig Landgrebe, Dorion Cairns, Simone de Beauvoir, Jean-Paul Sartre, Maurice Merleau-Ponty, Jacques Derrida and Giles Deleuze. In addition to its documentation and analysis of the historical reception of these works, this volume also illustrates the ongoing relevance of the Ideen, offering scholarly discussion of the issues raised by his ideas as well as by the figures who took part in critical phenomenological dialogue with them. Among the topics discussed are autism, empathy, the nature of the emotions, the method and practice of phenomenology, the foundations of ethics, naturalism, intentionality, and human rights, to name but a few. Taken together, these specially commissioned original essays offer an unrivaled overview of the reception of Husserl's Ideen, and the expanding phenomenological enterprise it initiated. They show that the critical discussion of issues by phenomenologists continues to be relevant for the 21st century.
