The turn of the century was accompanied by two historically significant phenomena. One was the emergence of computer networks as a vital component of advanced militaries and interdependent global economic systems. The second concerned China's rise on the global stage through economic reforms that led to sustained growth and military modernization. At the same time, Chinese government policies and actions have drawn international criticisms including persistent allegations of online espionage, domestic Internet censorship, and an increased military capability, all of which utilize computer networks. These threat perceptions are heightened by a lack of transparency. Unlike the United States or the North Atlantic Treaty Organization, China does not articulate its strategic doctrine. Further, open source material on this topic is often contradictory, cursory, and unclear due, in part, to the absence of consensus on cyber-related terminology and the infancy of this field. With a focus on the period 1998 to 2016, this book identifies and analyzes the strategic context, conceptual framework, and historical evolution of***

**Millions of people in the United States live with serious illnesses such as cancer, heart disease, chronic obstructive pulmonary disorder (COPD), amyotrophic lateral sclerosis, Parkinson's disease, and**

dementia"often for many years. Those facing serious illness have a range of interconnected medical and non-medical needs, and the way their care is financed has a large impact on the care they receive. Medicare is the predominant payer, but both Medicaid and private payers also play significant roles in financing care for serious illness. In an effort to address the complex needs of people with serious illness, public and private health care payers are testing innovative financing strategies and alternative payment models. These innovative approaches signal a gradual transition from the traditional-fee-for-service system that pays providers based on the quantity of services to a system based on the value of care provided and a heightened focus on improved quality of care at lower cost. **At a time when policies are increasingly against it, international migration has become the subject of great public and academic attention. This book departs from the dominant approach of studying international migration at macro level, and from the perspective of destination countries. The contributors here seek to do more than 'scratch the surface' of the migration process, by foregrounding the voices and views of Ethiopian youth-potential migrants and returnees-and of their sending communities. The volume focuses on the perspective and agency of these young people, both potential migrants and returnees, to better understand migration decision-making, experiences and outcomes. It brings together rarely documented cases of young men and women from several communities across Ethiopia, migrating to the Gulf and South Africa. Explaining the agency of local actors-prospective migrants, brokers and sending families- Youth on the Move illuminates the pervasive, persistent failure of state attempts to regulate migration. Moreover, it examines the financing of migration and the sharing of remittances, within a culturally situated moral economy. While accounts centered on economics and political violence are important, the contributors demonstrate compellingly that these factors alone cannot provide a full understanding of migration's complexity, nor of**

**its social realities.**

For most people, eyesight is part of everyday communication, social activities, educational and professional pursuits, the care of others, and the maintenance of personal health, independence, and mobility.
