It is a substantially revised and updated edition of the popular text by Robert B. Ash, offering a concise treatment that provides careful and complete explanations as well as numerous problems and solutions. An introduction presents basic definitions, covering topology of the plane, analytic functions, real-differentiability and the Cauchy-Riemann equations, and exponential and harmonic functions. Succeeding chapters examine the elementary theory and the general Cauchy theorem and applications, including singularities, residue theory, the open mapping theorem for analytic functions, linear fractional transformations, conformal mapping, and analytic mappings of one disk to another. The Riemann mapping theorem receives a thorough treatment, along with factorization of analytic functions. As an application of many of the ideas and results appearing in earlier chapters, the text ends with a proof of the prime number theorem.

Restructured and completely revised, this textbook first develops the theory of complex analysis, and then examines its geometrical interpretation and application to Dirichlet and Neumann boundary value problems. A discussion of complex analysis now forms the first three chapters of the book, with a description of conformal mapping and its application to boundary value problems for the two-dimensional Laplace equation forming the final two chapters. This new structure enables students to study theory and applications separately, as needed. In order to maintain brevity and clarity, the text limits the application of complex analysis to two-dimensional boundary value problems related to temperature distribution, fluid flow, and electrostatics. In each case, in order to show the relevance of complex analysis, each application is preceded by mathematical background that demonstrates how a real valued potential function and its related complex potential can be derived from the mathematics that describes the physical situation.

The topics from advanced calculus that are used (e.g., Leibniz's rule for differentiating under the integral sign) are proved in detail. Complex Variables is a subject which has something for all mathematicians. In addition to having applications to other parts of analysis, it can rightly claim to be an ancestor of many areas of mathematics (e.g., homotopy theory, manifolds). This view of Complex Analysis as "An Introduction to Mathematics" has influenced the writing and selection of subject matter for this book. The other guiding principle followed is that all definitions, theorems, etc.

An Introduction to Statistical Learning provides an accessible overview of the field of statistical learning, an essential toolset for making sense of the vast and complex data sets that have emerged in fields ranging from biology to finance to marketing to astrophysics in the past twenty years.
