Tremmel's approach demands that each generation both consider and improve the well-being of future generations. To measure the well-being of future generations Tremmel employs the Human Development Index rather than the metrics of utilitarian subjective happiness. The book thus answers in detailed, concrete terms the two most important questions of every theory of intergenerational justice: what to sustain? and how much to sustain?

He has developed a generation of remuneration and talent experts, helped define the field of practice, and made a significant contribution to the national level of excellence in these fields.

Headlines frequently appear that purport to highlight the differences among workers of different generations and explain how employers can manage the wants and needs of each generation. But is each new generation really that different from previous ones? Are there fundamental differences among generations that impact how they act and interact in the workplace? Or are the perceived differences among generations simply an indicator of age-related differences between older and younger workers or a reflection of all people adapting to a changing workplace? This book introduces the "Principle of Localization," which says that generational theory applies to each local nation or society. It gives fascinating details about many specific crisis wars, such as King Philip's war, World Wars I and II, Napoleon's invasion of Russia, the Peloponnesian War, Bolshevik Revolution, Taiping Rebellion, and so forth. Generational theory is also integrated with financial and technological forecasting, to show how they interact, and how to predict major financial crises. Recent books in the Generational Theory Book Series by the same author include "World View: War Between China and Japan: Why America Must Be Prepared" and "World View: Iran's Struggle for Supremacy -- Tehran's Obsession to Redraw the Map of the Middle East." These books analyze millennia of history for China and Iran, respectively, and predict each country's

future in view of its past. The new introduction includes the history and evolution of the original Fourth Turning theory by Bill Strauss and Neil Strauss, which focuses on popular American generational sociology (Millennials, etc.)

Rural Rides is the book for which the English journalist, agriculturist and political reformer William Cobbett is best known. An Avant-garde Theological Generation offers a clearer understanding of the Jesuit theologians and philosophers who comprised the group known the 'Fourvière Jesuits'. Led by Henri de Lubac and Jean Daniélou, they formed part of the nouvelle théologie, an influential French reform movement that flourished from the 1930s until its suppression in 1950. After identifying a certain lacuna in the secondary literature, Jon Kirwan remedies certain historical deficiencies by constructing a history both sensitive to the wider intellectual, political, economic, and cultural milieu of the French interwar crisis, and that establishes continuity with the Modernist crisis and the First World War. Kirwan examines the modern French avant-garde generations that have shaped intellectual and political thought in France, providing context for a historical narrative of the Fourvière Jesuits more sensitive to the wider influences of French culture. This historical narrative of the Fourvière Jesuits follows four stages. The study examines the influential older generations that flourished from 1893 to 1914, such as the Dreyfus generation, the generation of Catholic Modernists, and two generations of older Jesuits, which were instrumental in the Fourvière Jesuits' development. It explores the influence of the First World War and the years of the 1920s, during which the Jesuits were in religious and intellectual formation, relying heavily on unpublished letters and documents from the Jesuits archives in Paris (Vanves). Kirwan then analyses the crises of the 1930s, the emergence of the Fourvière Jesuits' wider generation, and their participation in the intellectual thirst for revolution. He explores the decade of the 1940s, which saw the rise to prominence of the members of the generation of 1930, who, thanks to their participation in the resistance, emerged from the Second World War, with significant influence on the postwar French intellectual milieu.
