Therefore, I will refer to the work of various literary and social scientists and critics such as Jeffrey Meyers and Sabrina Laurent, but also other scholars from different fields. In addition, I will depict that the events within the short story are intended to give an insight into the negative behavior of humans in order to serve as an example of what morally reprehensible behavior can result in. Nowadays it is common knowledge that Edgar Allan Poe is one of the most famous representatives when it comes to the involvement of personal experiences and the placement of hidden symbols in short stories and poems. The Masque of the Red Death is no exception and also represents one of Poe's most popular tales. It first appeared in Graham’s Magazine in May 1842 and, due to the time it was written, was part of the so-called "Masquerades" along with three other of Poe's stories.
