Medicine and astronomy are the oldest of all the sciences. They appear at first glance to be the original odd couple. Their union gave birth to a progeny that populated the Western world for more than two millennia. From an historical perspective, their

From the use of amphetamines and other stimulants in the early 20th century, to the use of testosterone and steroids by both the USSR and the United States during Cold War-era Olympics

games, to blood doping and EPO, to designer drugs, the history of doping in sports closely follows the medical and technological advances of our times. In the early 21st century, the possibility of genetically engineered athletes looms. Race is one of the most elusive phenomena of social life. While we generally know it when we see it, it's not an easy concept to define. Social science literature has argued that race is a Western, socio-political concept that emerged with the birth of modern imperialism, whether in the sixteenth century (the Age of
