

Formal Verification An Essential Toolkit For Modern Vlsi Design

This textbook is an introduction to the use of formal methods ranging from semantics of key programming constructs to techniques for the analysis and verification of programs. The authors use program graphs as the mechanism for representing the control structure of programs in order to find a balance between generality and conceptual complexity. The early chapters on program graphs and the Guarded Commands language are sufficient introduction for most readers to then enjoy a plug-and-play approach to the remaining chapters. These explain formal methods for analysing the behaviour of programs in various ways ranging from verification, via program analysis and language-based security, to model checking. The remaining chapters present language extensions with procedures and concurrency and cover their semantics. The book is suitable for advanced undergraduate and graduate courses in software development, and the text is supported throughout with exercises of varying grades of difficulty. The authors have developed an online learning environment that allows students to create examples beyond those covered in the main text, and in the book appendices they present programming projects aimed at implementing central parts of the development using the functional language F#.

In Software Abstractions Daniel Jackson introduces an approach to software design that draws on traditional formal methods but exploits automated tools to find flaws as early as possible. This approach -- which Jackson calls "lightweight formal methods" or "agile modeling" -- takes from formal specification the idea of a precise and expressive notation based on a tiny core of simple and robust concepts but replaces conventional analysis based on theorem proving with a fully automated analysis that gives designers immediate feedback. Jackson has developed Alloy, a language that captures the essence of software abstractions simply and succinctly, using a minimal toolkit of mathematical notions. This revised edition updates the text, examples, and appendixes to be fully compatible with Alloy 4.

The use of mathematical methods in the development of software is essential when reliable systems are sought; in particular they are now strongly recommended by the official norms adopted in the production of critical software. Program Verification is the area of computer science that studies mathematical methods for checking that a program conforms to its specification. This text is a self-contained introduction to program

verification using logic-based methods, presented in the broader context of formal methods for software engineering. The idea of specifying the behaviour of individual software components by attaching contracts to them is now a widely followed approach in program development, which has given rise notably to the development of a number of behavioural interface specification languages and program verification tools. A foundation for the static verification of programs based on contract-annotated routines is laid out in the book. These can be independently verified, which provides a modular approach to the verification of software. The text assumes only basic knowledge of standard mathematical concepts that should be familiar to any computer science student. It includes a self-contained introduction to propositional logic and first-order reasoning with theories, followed by a study of program verification that combines theoretical and practical aspects - from a program logic (a variant of Hoare logic for programs containing user-provided annotations) to the use of a realistic tool for the verification of C programs (annotated using the ACSL specification language), through the generation of verification conditions and the static verification of runtime errors.

Introductory treatment begins with set theory and fundamentals of Boolean algebra, proceeding to concise accounts of applications to symbolic logic, switching circuits, relay circuits, binary arithmetic, and probability theory. 1961 edition.

The most visible use of computers and software is processing information for human consumption. The vast majority of computers in use, however, are much less visible. They run the engine, brakes, seatbelts, airbag, and audio system in your car. They digitally encode your voice and construct a radio signal to send it from your cell phone to a base station. They command robots on a factory floor, power generation in a power plant, processes in a chemical plant, and traffic lights in a city. These less visible computers are called embedded systems, and the software they run is called embedded software. The principal challenges in designing and analyzing embedded systems stem from their interaction with physical processes. This book takes a cyber-physical approach to embedded systems, introducing the engineering concepts underlying embedded systems as a technology and as a subject of study. The focus is on modeling, design, and analysis of cyber-physical systems, which integrate computation, networking, and physical processes. The second edition offers two new chapters, several new exercises, and other improvements. The book can be used as a textbook at the advanced undergraduate or introductory graduate level and as a professional reference for practicing engineers and computer scientists. Readers should have some familiarity with machine structures, computer programming, basic discrete mathematics and algorithms, and signals and systems.
