The software described in this book uses only SPX for the options because I discovered that when I used other underlying stocks or indices such as Google and SPY, SPX usually finished best. SelfAdapSPXweeklyVLT. Trade Monster's affiliate OptionsHouse can be used for Weekly Options trading if you have a minimum of \$2,000 in the account. I use 1/4 of the capital = \$500 for Margin to generate about \$100 for the week or \$400 for the Month. In other words you get 90% return per month on \$500 margin. Remember the weekly in-out trades should be no more than 2 per week to avoid being designated a day trader by your broker which requires a minimum of \$25,000 in your account.
