Faced with budget challenges, many districts cannot afford to hire an outside consultant to conduct a formal evaluation of their gifted programs. **Abstract: Guidelines for the evaluation of educational programs have been designed to cover a broad spectrum of applications by suggesting step-by-step procedures for gathering, analyzing and interpreting information on attitudes, functions, or achievement.
