What makes PTS different for soldiers is that they are subject to frequent traumatic events over a long period of time. People respond differently to traumatic events, some are more resilient than others. Frequency, duration, and the extreme nature of the event all play a role in recovery. A major component of PTS is the moral dissonance we experience. The event can completely destroy our belief system, the ideas we held that made sense of the world we live in. At any point in time we are a summation of what we know and the experiences we have gone through. Events and information change how we see the world and in effect change who we are. A traumatic event can be so life changing that we are in effect a different person and after a traumatic event, the new you. In order to recover from PTS, it is imperative we reconstruct a new belief system that encompasses our new reality and the new you. In Just War. I (Tom Newman) recount the events that destroyed my worldview and fundamentally changed the person I was. The Company I was with in Vietnam experienced a 97 percent casualties and fatalities. Within my first 30 days in country we had a friendly fire incident that killed eleven and severely wounded nineteen of my fellow troopers. I also witnessed the aftermath of the regular assassination of four year old children. Additionally, when we retook the city of Hue we found the shallow graves of 2,800; judges, doctors, clergy, policeman, and politicians, anyone that could organize a resistance against the communists. It was a very long process for me to make sense of my new realities and the new me. My other book: A Brief History of the Bible Things To Come, is the information I needed to reconstruct a new worldview bases on my experiences and the new person I had become. If you want to get your life back after suffering from PTS, it is imperative you find a new worldview for the new you.

There are many theories about what caused the Great Depression, and the truth is that there is no simple answer. Rather, a perfect storm of events came together and changed the lives of millions of people. One of the first signs of this dark period was the stock market crash in October 1929. In the aftermath, the country fell into the Great Depression, the longest and most significant economic depression since the Civil War. Through most of the 1920s, however, and the stock market had reached new highs. People were making money in the stock market and having a grand time, so much so that few noticed the dark clouds forming on the horizon. By the end of the decade, industrial production had begun to decline, while unemployment was steadily rising. Stock market prices were plummeting from their peak in September 1929, and sales reached a crescendo in late October. On October 29, over sixteen million shares were traded in just one day. Billions of dollars were lost, with thousands of investors wiped out, and stock tickers were running hours behind because they were simply unequipped to manage this unprecedented amount of trading. The crash was not the only cause of the Great Depression, but it was certainly a symptom of a larger set of problems. Earlier in 1929, Herbert Hoover won the presidency under a wealth and prosperity platform. He made several unsuccessful attempts to prevent the economy from weakening during his administration. Despite his best efforts, banks continued to fail, and more Americans entered the ranks of unemployment. No one understood the extent of this economic downturn. But the election of 1932 brought Democrat Franklin D. Roosevelt into the White House by a landslide. Roosevelt wasted no time, proposing extensive legislation called the New Deal to create new jobs, revitalize the banks, and give hope to the American people. Some of the New Deal programs were successful, while other fell short; but by the end of the 1930s, things had finally begun to improve. However, it would take the massive spending required during World War II for the economy to return to where it was a decade before. Many ancient civilizations have influenced and inspired people in the 21st century. The Greeks and Romans continue to fascinate the West today. But of all the world's civilizations, none have intrigued people more than the Mayans, whose culture, astronomy, language, and mysterious disappearance all continue to captivate people. In 2012 especially, there was a renewed focus on the Mayans, whose advanced calendar led many to speculate the world would end on the same date the Mayan calendar ends. The focus on the "doomsday" scenario, however, overshadowed the Mayans' true contribution to astronomy, language, sports, and art. Unlike most of the world's sacred books – the Quran, the Bible or the I-Ching for example – nobody knows the universal name, if there ever was one, for the Maya's collection of myths. Instead, the title that has been passed down, the "Popol Vuh," appears to be the specific title given to a particular copy of these tales. Its meaning, roughly translated as the Council Book, refers to the special role of this text: it was the shared property of the council of lords that ruled the Quiché kingdom and was apparently regularly consulted by that body for advice to guide their rule. However, in the opening sections, the scribes who penned the text also give it several other names, including "the Light That Came from Beside the Sea," "Our Place in the Shadows" and "The Dawn of Life" (pg 63). All of these names were originally in K'ichean Maya, the language spoken by the Maya of the Quiché Kingdom and its neighboring regions. The first of these names refers to a pilgrimage by the second generation of Quiché lords in Part V to the Yucatan coast to acquire a copy of at least a portion of the original text. The second refers to Part IV, the period before the first Dawn ("the Shadows") when the ancestral Quiché earned their particular right to rule. The final name refers to Part I, when the first gods created all of the various parts of life. This multiplicity of names and titles for sacred works is not uncommon, and perhaps comparable to the Bible being referred to as "the Good Book" or (in reference to the New Testament) "the Good News" or the "Gospel." The name Popol Vuh is itself controversial as the original text actually spells the name three different ways: "Popol Vuh," of course, but also "Pop Wuj" and "Popol Wuj." In general, the most correct form in contemporary Quiche spelling is probably "Popol Wuj"), but as the text is best known in English with the word "Vuh", this convention will be maintained here (Benriik 2014). There are a number of translations and editions of the Popol Vuh, which vary considerably in quality. Many early editions were not informed by the latest scholarship in Maya linguistics and sometimes the ways they translate names in particular can vary. This text will use the Second Edition (1996), translated by Dennis Tedlock and published by Simon and Schuster, for all of its quotations and page citations. A final set of chapters in Part VII examines postwar and Cold War experiences that varied among the four Communist regimes as well as for non-Communist Greece. Lastly, a brief Epilogue takes the narrative past 1989 into the uncertainties that persist in Yugoslavia's successor states and its neighbors. Providing fresh analysis from recent scholarship, the brief and accessible chapters of the Handbook address the general reader as well as students and scholars. For further study, each chapter includes a short list of selected readings.
