For several years there has been a growing interest in understanding the dynamics of parasites in ecosystems, as well as the diversity of ways in which they influence ecosystem functioning through their effects on host populations and communities. Ecologists, epidemiologists, evolutionary biologists, and other scientists are increasingly coming to realise that parasites must be taken into account when studying ecosystems. Parasitism and Ecosystems summarizes current knowledge on this topic, providing a comprehensive overview for researchers and students. It represents the first synthesis of both the roles and the consequences of pathogens in ecosystems, utilising well-documented case-studies to illustrate the main issues as well as identifying prospects for future research.

Given the central role of the food and agriculture system in driving so many of the connected ecological, social and economic threats and challenges we currently face, Rethinking Food and Agriculture reviews, reassesses and reimagines the current food and agriculture system and the narrow paradigm in which it operates.

Rethinking Food and Agriculture explores and uncovers some of the key historical, ethical, economic, social, cultural, political, and structural drivers and root causes of unsustainability, degradation of the agricultural environment, destruction of nature, short-comings in science and knowledge systems, inequality, hunger and food insecurity, and disharmony. It reviews efforts towards 'sustainable development', and reassesses whether these efforts have been implemented with adequate responsibility, acceptable societal and environmental costs and optimal engagement to secure sustainability, equity and justice. The book highlights the many ways that farmers and their communities, civil society groups, social movements, development experts, scientists and others have been raising awareness of these issues, implementing solutions and forging 'new ways forward', for example towards paradigms of agriculture, natural resource management and human nutrition which are more sustainable and just. Rethinking Food and Agriculture proposes ways to move beyond the current limited view of agro-ecological sustainability towards overall sustainability of the food and agriculture system based on the principle of 'inclusive responsibility'. Inclusive responsibility encourages ecosystem sustainability based on agro-ecological and planetary limits to sustainable resource use for production and livelihoods. Inclusive responsibility also places importance on quality of life, pluralism, equity and justice for all and emphasises the

health, well-being, sovereignty, dignity and rights of producers, consumers and other stakeholders, as well as of nonhuman animals and the natural world. Explores some of the key drivers and root causes of unsustainability, degradation of the agricultural environment and destruction of nature Highlights the many ways that different stakeholders have been forging 'new ways forward' towards alternative paradigms of agriculture, human nutrition and political economy, which are more sustainable and just Proposes ways to move beyond the current unsustainable exploitation of natural resources towards agroecological sustainability and overall sustainability of the food and agriculture system based on 'inclusive responsibility'

This book represents the proceedings of the first major international meeting dedicated to discuss environmental aspects of produced water. The 1992 International Produced Water Symposium was held at the Catamaran Hotel, San Diego, California, USA, on February 4-7, 1992. The objectives of the conference were to provide a forum where scientists, regulators, industry, academia, and the environmental community could gather to hear and discuss the latest information related to the environmental considerations of produced water discharges. It was also an objective to provide a forum for the peer review and international publication of the symposium papers so that they would have wide availability to all parties interested in produced water environmental issues. Produced water is the largest volume waste stream from oil and gas production activities. Onshore, well over 90% is reinjected to subsurface formations. Offshore, and in the coastal zone, most produced water is discharged to the ocean. Over the past several years there has been increasing concern from regulators and the environmental community. There has been a quest for more information on the composition, treatment systems and chemicals, discharge characteristics, disposal options, and fate and effects of the produced water. As so often happens, much of this information exists in the forms of reports and internal research papers. This symposium and publication was intended to make this information available, both for open discussion at the conference, and for peer review before publication.

**Humans have moved organisms around the world for centuries but it is only relatively recently that invasion ecology has grown into a mainstream research field. This book examines both the spread and impact dynamics of invasive species, placing the science of invasion biology on a new, more rigorous, theoretical footing, and proposing a concept of adaptive networks as the foundation for future research. Biological invasions are considered not as simple actions of invaders and reactions of invaded ecosystems, but as co-evolving complex adaptive systems with emergent features of network complexity and invasibility. Invasion Dynamics focuses on the ecology of invasive species and their impacts in recipient social-ecological systems. It discusses not only key advances and**

challenges within the traditional domain of invasion ecology, but introduces approaches, concepts, and insights from many other disciplines such as complexity science, systems science, and ecology more broadly. It will be of great value to invasion biologists analyzing spread and/or impact dynamics as well as other ecologists interested in spread processes or habitat management.

Primary productivity in the sea accounts for ~30% of the total global annual production. When we think of "climate change," we think of man-made global warming, caused by greenhouse gas emissions. But natural climate change has occurred throughout human history, and populations have had to adapt to the climate's vicissitudes. Anthony J. Climate Change and the Health of Nations shows how the natural environment has vast direct and indirect repercussions for human health and welfare. McMichael takes us on a tour of human history through the lens of major transformations in climate. From the very beginning of our species some five million years ago, human biology has evolved in response to cooling temperatures, new food sources, and changing geography. As societies began to form, they too adapted in relation to their environments, most notably with the development of agriculture eleven thousand years ago. Agricultural civilization was a Faustian bargain, however: the prosperity and comfort that an agrarian society provides relies on the assumption that the environment will largely be stable. Indeed, for agriculture to succeed, environmental conditions must be just right, which McMichael refers to as a "Goldilocks phenomenon." Global warming is disrupting this balance, just as other climate-related upheavals have tested human societies throughout history. As McMichael shows, the break-up of the Roman Empire, the bubonic Plague of Justinian, and the mysterious collapse of Mayan civilization all have roots in climate change. Why devote so much analysis to the past, when the daunting future of climate change is already here? Because the story of mankind's previous survival in the face of an unpredictable and unstable climate, and of the terrible toll that climate change can take, could not be more important as we face the realities of a warming planet. This sweeping magnum opus is not only a rigorous, innovative, and fascinating exploration of how the climate affects the human condition, but also an urgent call to recognize our species' utter reliance on the earth as it is.

Disease Ecology highlights exciting advances in theoretical and empirical research towards understanding the importance of community structure in the emergence of infectious diseases. The chapters in this book illustrate aspects of community ecology that influence pathogen transmission rates and disease dynamics in a wide variety of study

systems. The innovative studies presented here communicate a clear message: studies of epidemiology can be approached from the perspective of community ecology, and students of community ecology can contribute significantly to epidemiology.

**As human populations grow, so do the resource demands imposed on ecosystems, and the impacts of anthropogenic use and abuse are becoming ever more apparent. This has led to the development of the concept of ecosystem services, which describes the beneficial functions provided by ecosystems for human society. Ecosystem services are limited and hence threatened by over-exploitation, and there is an urgent imperative to evaluate trade-offs between immediate and long-term**

human needs and to take action to protect biodiversity, which is a key factor in delivering ecosystem services. To help inform decision-makers, economic value is increasingly being associated with many ecosystem services and is often based on the replacement with anthropogenic alternatives. The on-going challenges of maintaining sustainable ecosystems and prescribing economic value to nature is prompting multi-disciplinary shifts in how we recognise and manage the environment. This volume brings together emerging topics in environmental science, making an excellent source for policy makers and environmental consultants working in the field or related areas. Ecosystem Services also serves as a concise and referenced primer for advanced students and researchers in environmental science and management.

This collection of eleven new essays contains the latest developments in analytic feminist philosophy on the topic of pornography.
