*There is a growing trend for graduate schools of social work to offer students the option of receiving dual degrees, which gives students the ability to obtain a Master of Social Work (MSW) along with a second graduate degree in less time than it would take to complete each degree individually. As of 2005, there were approximately 30 different types of degrees that could be combined with graduate studies in social work--one of which is a Master of Divinity (M. Div.). Very little is known about the effectiveness of such programs and the experiences of graduates completing them. The aim of this study was to describe the lived experiences of persons receiving an MSW and an M. Div. from dual degree programs. The National Association of Social Workers (NASW) includes religious and spiritual beliefs in its definition of culturally competent practice within the code of ethics. Dual degree graduates are trained to engage in culturally competent practice by virtue of being extensively trained in the cultural context of the church through their M. Div. degree and extensively trained in the context of social work service delivery through their MSW degree. Dual degree programs in social work and divinity are quite timely given that 96% of Americans say they believe in God or a universal spirit. Phenomenology seeks to understand a particular phenomenon from the point of view of those who have experienced it. With this in mind, this study reports the findings resulting from interviews conducted with 16 graduates regarding their experiences while in a dual degree program. One of the key phenomenological patterns that emerged in all the interviews conducted was that dual degree graduates want "journey companions," i.e. persons who share their worldview.*

The concepts of hope and self-employability were studied among Masters of Social Work (MSW) students who are expected to graduate in Spring 2017. Demographics, self-perceived employability, and hope were measured using a self-designed survey. Participants included MSW students from the following universities: California State University of Northridge, University of Southern California, and University of California Los Angeles. The averages found for the Hope and Self-Employability questions among the MSW students were high. Participants who identified as a recipient of a work-back stipend such as California Social Work Education Center (CalSWEC), Department of Mental Health (DMH), Geriatric Social Work Education Consortium (GSWEC), and University Consortium for Children and Families (UCCF) declared they were hopeful they could obtain employment in the first six months after earning their MSW degree. A large portion of the participants was also hopeful they had acquired the social work skills necessary to find employment after graduation.

Decolonizing Wealth is a provocative analysis of the dysfunctional colonial dynamics at play in philanthropy and finance. Evidence suggests that mandatory individual counseling could be helpful for students in Masters of Social Work (MSW) programs. However, little is known about how MSW students would perceive such a requirement, or whether these perceptions differ by program specialization. This research study explored perceptions about potentially mandatory individual counseling during MSW programs amongst current students enrolled in the MSW program at California State University, Sacramento. A sample of 134 students was collected via non-probability

convenience sampling. Students were asked to complete a short survey during their research class. Results demonstrate that most students were highly supportive of mandatory individual counseling for MSW students, showing a mean of 3.85 with 1 being strongly disagree. An Analysis of Co-Variance (ANOVA) was conducted to determine whether there were differences in mean scores supporting mandatory counseling between program specializations; the results suggest no significant differences. This study reflects the need for further research and possible implementation of personal psychotherapy in graduate social work programs.

The authors explain that victims cannot stop their battering partners from battering and virtually all batterers choose to harm their partners in a premeditated fashion. The authors provide practical steps and suggestions for victims who want to leave and stay away from their violent partners and for friends who want to help battered gay men. Chapters describe the scope of the problem and refute myths and misconceptions. There are several detailed theory chapters in which the authors explain why gay



men's domestic violence occurs, who the batterers are, who the victims are at different stages of victimization, and how domestic violence can be stopped. A visionary, wide-ranging governmental and private plan of action is introduced, including lists of necessary laws and policies, as well as outlines of strong education, training, and advertising problems needed in various sectors of society.
