This book explains and illustrates the rules that are given in the Eurocodes for designing steel structures subjected to fire. After the first introductory chapter, Chapter 2 explains how to calculate the mechanical actions (loads) in the fire situation based on the information given in EN 1990 and EN 1991. Chapter 3 is dedicated to the models which represent the thermal actions created by the fire. Chapter 4 describes the procedures to be used to calculate the temperature of the steelwork from the temperature of the compartment and Chapter 5 shows how the information given in EN 1993-1-2 is used to determine the load bearing capacity of the steel structure. Chapter 6 presents the essential features that characterize the advanced calculation models, for thermal and mechanical response. The methods used to evaluate the fire resistance of bolted and welded connections are described in Chapter 7. Chapter 8 describes a computer program called `Elefir-EN? which is based on the simple calculation model given in the Eurocode and allows designers to quickly and accurately calculate the performance of steel components in the fire situation. Chapter 9 looks at the issues that a designer may be faced with when assessing the fire resistance of a complete building. This is done via a case study and addresses most of the concepts presented in the previous chapters. For this second edition the content has been revised and extended. The book contains some new sections, e.g. a comparison between the simple and the advanced calculation, as well as additional examples.

This book examines the dramatic increase in automotive assembly plants in the former Socialist Central European (CE) nations of Czechia, East Germany, Hungary, Poland, and Slovakia from 1989 onwards. Enticed by relatively lower-wage labour and significant government incentives, the world's largest automakers have launched more than 20 passenger car assembly complexes in CE nations, with production accelerating dramatically since 2001. As a result, the annual passenger car production in Western Europe declined by more than 20% between 2001 and 2015, and alternatively in the CEE it increased by nearly 170% during this period. Drawing on case studies of 25 current and former foreign-run assembly plants, the author presents a rare historical account of automotive foreign assembly plants in the CE following this dramatic geographic shift. This book will expand the knowledge of policy-makers in Europe in relation to their pursuits of FDI and will be of great interest to scholars and students of business, economic history, political science, and development.

This e-book details the most interesting and important characteristics of the automobiles, car maintenance, styling features, car body style, the standard classification of the cars, an history of the automobiles, introduction in the automotive industry, and the traffic code, rules and signs. An automobile, usually called a car (an old word for carriage) or a truck, is a wheeled vehicle that carries its own engine. Older terms include horseless carriage and motor car, with "motor" referring to what is now usually called the engine. It has seats for the driver and, almost without exception, for at least one passenger. The automobile was hailed as an environmental improvement over horses when it was first introduced. Before its introduction, in New York City, over 10,000 tons of manure had to be removed from the streets daily. However, in 2006 the automobile is one of the primary sources of worldwide air pollution and cause of substantial noise and health effects.

The automobile sector is one of the most archetypal global industries and is seen by many as one of the main drivers behind the homogenisation of world markets due to firms' internationalization strategies and the social practices that firms impose. This book argues that this is not entirely the case due to the heterogeneity of firms and the diversity of strategies pursued. It highlights the diversity and forms of internationalization and the preference for regionalization rather than globalization that has occurred over the past decade.
